Test Suites Activation and Deactivation schedule

1.1 About this bulletin

This Operations Bulletin No. 19/2nd Edition is an update of Operations Bulletin N° 19.

The Product Qualification Operations Bulletin aims to present the GlobalPlatform Product Qualification Process changes and updates.

When an effective date is mentioned for a change, the change must be implemented as of that date; Changes for which no effective date is specified in the article are effective immediately.

1.1 Summary

Following the development of the Test Suite for the SE configuration 2.0, the Test Suite for CIC configuration 2.0 has been enhanced with the extension of tests coverage as well as flexibility of the interfaces supported during products qualification. Therefore, the following new Test Suites have been released:

- SE configuration v2.0 Test Suite v1.7.0
- CIC configuration v2.0 Test Suite v2.1.0
- UICC configuration v2.0 Test Suite v3.1.0
- Financial configuration v1.0 Test Suite v1.1.0

Additionally, two independent test packages

- SCP11 (A and B) – Amendment F
- ELF Upgrade – Amendment H

Can be used as an extension to product qualification based on:

- UICC configuration v2.0 Test Suite v3.1.0
- CIC configuration v2.0 Test Suite v2.1.0
- Financial configuration v1.0 Test Suite v1.1.0

1.2 Test Suites activation

The following Test Suites will be active in the laboratories from September 2, 2019:

- SE configuration v2.0 Test Suite v1.7.0
- UICC Configuration v2.0 Test Suite v3.1.0,
- CIC Configuration v2.0 Test Suite v2.1.0
- Financial Configuration v1.0 Test Suite v1.1.0

1.3 Test Suites deactivation schedule

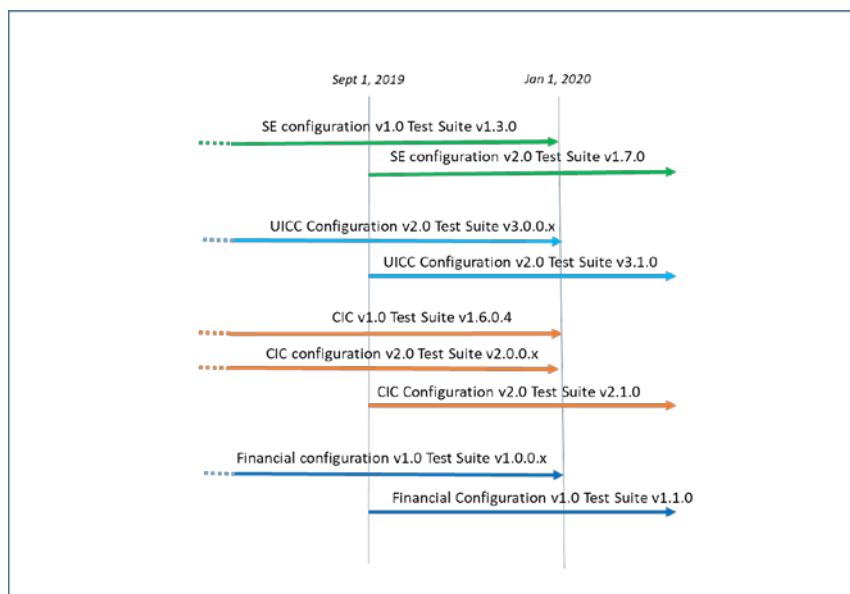
The following current Test Suites shall not be used for new product qualification after September 2, 2019:

- ~~SE configuration v1.0 Test Suite v1.3.0~~
- ~~CIC configuration v1.0 Test Suite v1.6.0.4~~

The following current Test Suites shall not be used for new product qualification after December 31, 2019:

- SE configuration v1.0 Test Suite v1.3.0
- UICC Configuration v2.0 Test Suite v3.0.0.x,
- CIC configuration v1.0 Test Suite v1.6.0.4
- CIC configuration v2.0 Test Suite v2.0.0.x
- Financial configuration v1.0 Test Suite v1.0.0.x
