## Course Description

**The two-day program offers an overview of SE technology, before sharing an in-depth overview of mobile wallets.**

### Day 1

Participants will explore GlobalPlatform's role in digital security and understand SE technology in detail.

### Day 2

Participants will go deeper into deployments on embedded SEs and eSIMs, two SE form factors available on most smartphones. The course will also explore other GlobalPlatform technologies that can support the EUDI initiative, such as Cryptographic Service Providers (CSP) and Protection Profiles for CSP. The session will cover Secured Applications for Mobile (SAM), including the SAM configuration, eSIM and SAM Public Key Infrastructure (PKI), and its deployment in an eID wallet use case. The one-to-many deployments model (involving SE Management Service & Decentralized SE Management) will be examined in detail. The day concludes with an interactive EUDI wallet workshop, offering practical deployment scenarios.
